ADDRESSING HATE CRIME IN MID-ULSTER

Hate crime continues to affect the lives of many across Mid-Ulster. Factors include a lack of understanding, limited representation, service gaps and mistrust. To address, we need a united, grassroots-led approach that recognises the value and dignity of all people.

This Mini-Manifesto was developed from workshops and conversations led by Victim Support NI and local partners through the We Stand Together OCN Level 3 Pilot Training in March-April 2025. The issues, asks and commitments included in this mini-manifesto reflect the views and experiences of the training participants.

It is a living document, intended as a contribution to addressing hate crime in Mid Ulster. Other voices and solutions are welcomed.







Mid-Ulster is a district marked by richness in heritage and growing diversity — yet significant challenges remain:

- Poor social cohesion, fueled by language and cultural barriers
- Lack of education on prejudice and hate crime
- Disinformation and harmful narratives online and in the media
- Delays in justice processes and lack of trust in reporting pathways
- A leadership and policymaking gap that fails to reflect local demographics
- Disconnection between services and community needs
- Inadequate early intervention strategies, particularly for children and families
- A benefits system that traps people in cycles rather than offering ways out
- Gaps in addressing gender-based violence, domestic abuse and age-related vulnerabilities







THE ISSUES



Several recurring themes were identified in Mid-Ulster:

Social Cohesion & Cultural Understanding

Community divisions are reinforced by cultural, religious and language barriers. There is a lack of understanding of both one's own and others' backgrounds — leading to mistrust, stereotyping and hate crimes.

Representation & Accountability

Local government, public services and leadership do not reflect the area's demographic reality, with ethnic minorities underrepresented across decision-making spaces.

Delays in Justice & Reporting

Hate crime victims face long waits from incident to resolution, discouraging reporting. There is also a gap in disability and cognitive-awareness training for key frontline services and across the criminal justice system.

Misinformation & Media Narratives

Harmful and false narratives, both local and global, shape public attitudes and increase prejudice. A lack of positive storytelling and myth-busting worsens the divide.







THE ISSUES



From patchy public service delivery to a rigid benefits system, many residents feel let down. Vulnerable groups are left unsupported — especially in cases of domestic abuse, gender-based violence and age-related issues.

Empathy Fatigue & Apathy in Services

A pervasive public service culture of 'passing the buck' often leaves hate crime and community safety issues unresolved, with responsibility bouncing between departments.

OUR ASKS

(WHAT WE WOULD LIKE TO SEE HAPPEN...)

Health & Justice Collaboration

Work with the health sector to improve support for vulnerable people — including better communication with families and more transparency.

Policing & Disability Awareness

Build deeper PSNI understanding of cognitive and neurodivergent conditions.

Shared Responsibility for Integration

Migrant and local communities should be supported to learn from each other. Integration must be two-way, respectful and grounded in empathy.

• Dialogue & Difficult Conversations

Break down the discomfort that has blocked conversations around difference. Focus on shared interests, not just identity.

Early Intervention & Education

Promote anti-prejudice learning from nursery age. Evaluate impact via qualitative feedback and curriculum change.



Family & Community Engagement

Involve parents — especially those outside typical community schemes — in anti-hate initiatives to tackle root causes at home.

Better Media & Messaging

Champion responsible journalism and community-led storytelling that highlights positive examples and promotes resilience.

Community-Led Support & Reporting

Empower local organisations to support third-party hate crime referrals and connect people to justice pathways

• Inclusive Public Services

Improve service standards. Train public bodies iin cultural competence and ensure accountability.

Addressing Vulnerabilities

Tackle gender-based violence, domestic abuse, and age-related marginalisation through holistic, intersectional policies.

OUR ASKS

Rural Affairs

Ensure that rural areas' affairs, related to hate crime and wider vulnerabilities – like those of relevance to many in Mid-Ulster – are sufficiently heard, represented and addressed at the NI-wide level, thus ensuring public policy avoids urban biases.

OUR COMMITMENTS

(WHAT WE WILL DO...)

Apply Global Solutions Locally Learn from international models of best practice and adapt them to the Mid-Ulster context.

Root Actions in Community Voice Use surveys and engagement tools to check whether our work reflects real community needs

Promote Empathy Over Apathy Drive cultural change through active listening, intercultural dialogue and creative programmes.

Arts, Heritage & Sports as Connectors Use cultural and community events to build trust — not just awareness campaigns.

Challenge Misinformation & Fear Build confidence in communities to talk across divides — and counteract silence with strength.

Create Inclusive Spaces

Provide forums for exploration of difficult topics, with emotional support and mutual respect at the core.

OUR COMMITMENTS

Regular Check-Ins & Evaluation

Meet quarterly to track progress, adapt to lessons and stay accountable.

• Encourage Responsible Citizenship

Train more people in active bystanding, challenge entitlement cultures and support pathways back into employment.

Strengthen Local Capacity

Identify and grow existing skills within ethnic minority communities and build leadership through tailored training.

• Keep Asking: "Who's Not Here?"

Commit to diversity of voices and bring underrepresented people into the fold — including those most affected by hate.

• Address Benefits System Gaps

Lobby local/national political leaders to instil a system that supports the most vulnerable while moving those ready and capable back into meaningful contribution to society. Develop a nuanced system that avoids 'throwing money at the problem' and strikes a balance between empathy, personal responsibility and balanced budgets.



• Greater Social Cohesion

Communities will be safer, stronger and more connected — with hate crime reduced.

Informed, Empathetic Youth

Children will grow up understanding difference, confident in themselves and prepared to live well with others.

Engaged Families & Parents

Intergenerational cycles of prejudice can be broken through family-led learning and participation.

• Improved Trust in Authorities

PSNI and public services will be more responsive, and victims more willing to report with confidence.

• Greater Representation in Leadership and Civil Society

More people from ethnic minority and underrepresented backgrounds will take up leadership roles, ensuring decisions reflect the reality of Mid-Ulster's communities.



- Cultural Understanding Normalised from a Young Age Early education and anti-hate curriculum development will build long-term social resilience.
- Reduced Misinformation and Polarisation
 Proactive myth-busting and positive storytelling will shift the narrative toward inclusion and understanding.
- Stronger Community Bonds Across Differences
 Shared events and meaningful interaction will
 increase mutual respect and collective identity
 across all communities.
- "Making it Make Sense" Everywhere Instilling a socioeconomic system based in effective advocacy which is fluid, capable of selfreflection and learning, and able to target systemic issues with nuance, precision and haste, promoting community ownership of the Council's future and fostering a culture in Mid-Ulster that others elsewhere seek to duplicate.

This Mini-Manifesto is a living document — shaped by and for the people of Mid-Ulster. We welcome further collaboration, feedback and action from anyone committed to building a safer, more inclusive community.
